Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) on the Rs. 8.90 crore bank facilities of Vimal Platinum Private Limited (VPPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Vimal Platinum Private Limited (VPPL) was incorporated in 2007 by Rajesh Laddha and Mukesh Laddha. The company is engaged in the manufacturing of fabrics (Finished and Grey Fabrics) at Bhilwara (Rajasthan).

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
