Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B+**' (read as **ACUITE B Plus**) and the short-term rating of '**ACUITE A4**' (read as **ACUITE A Four**) on the Rs.9.80 Crore bank facilities of Schnell Energy Equipments Private Limited (SEPL). The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

About the Company

The Coimbatore-based Schnell Energy Equipments Private Limited (SEPL) was incorporated in 2008 by Mr. Ganapathy Jaganathan and Mr. Jaganathan Nithin. The company is engaged in manufacturing, erection and commissioning of control panels (C- Plate Control Panel and Starter Control Panels) and caters to the electrical industry.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.
