## **Rating Rationale**

Acuité has reaffirmed the long-term rating of 'ACUITE B+' (read as ACUITE B plus) and short term rating of ACUITE A4 (read as ACUITE A four) on the Rs. 10.00 crore bank facilities of Envision Network Technologies Private Limited (ENTPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

Envision Network Technologies Private Limited (ENTPL) is a Bangalore based company incorporated in February 2000 by Mr. Ashok Deshpande and Mr. R Muralidharan. ENPL is engaged in Video Surveillance which includes Products & Projects, and rendering infrastructure management services in PDA/Network Technologies. Apart from this, the company leases four office spaces of 25000 square feet area.

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.
