Rating Rationale

Acuité has withdrawn the long term rating of '**ACUITE B+**' (read as **ACUITE B plus**) and the short term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs.8.00 Cr. bank facilities of PDP International Private Limited (PIPL). The rating continuous to be flagged as an 'Issuer Not-Cooperating' based on best available information.

The rating is being withdrawn on account of the request received from the company and the NOC received from the banker as per Acuité's policy on withdrawal of ratings.

About the Company

PDP International Private Limited (PDP) was established in the year of 1995 as a private limited company by Mr. Pramod Kumar Srivastava and Mrs. Rupa Srivastava. The company is engaged in providing freight and forwarding services along with storage and warehousing and transportation & handling. PDP has its own warehouse of 50,000 sq. ft. in Kolkata.

Non-cooperation by the issuer/borrower

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer / borrower failed to submit such information before the due date.

Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with an unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.
