## Rating Rationale

Acuite has reaffirmed long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) on the Rs. 9.20 crore bank facilities of Special Ceramics Private Limited. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

## About the Company

The Delhi based, Special Ceramics Private Limited was incorporated in 1988 and started its operations in 1991 by Anisul Hasan Rizvi and Sushil Kumar Agarwal. It is engaged in manufacturing of refractory bricks and monolithic as well as other refractory items for glass, cement and carbon black industry. It has installed capacity of 7200 MT/ annum. The company has its own research and development unit located at Bhiwadi (Rajasthan) along with its manufacturing facility.

## Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

## Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuite endeavored to gather information about the entity/industry from the public domain. Therefore, Acuite cautions lenders and investors regarding the use of such information, on which the indicative credit rating is based.
