Acuité has downgraded the long term rating to '**ACUITE BB** (read as ACUITE double B) from '**ACUITE BB+** (read as ACUITE double B plus) and review the short term rating of '**ACUITE A4+**' (Read as ACUITE A four plus) on the Rs. 17.00 crore bank facilities of Hyprecision Hydraulik (HH). The rating continues to be flagged as "Issuer Not-Cooperating" and is downgraded on account of information risk.

HH is a Mumbai-based company, incorporated in 2011 by Mr. Suresh Rajani and Mr. Gaurav Rajani. The company is engaged in design, engineering, installation, commissioning, maintenance of hydraulic systems and equipment for the marine sector.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
