Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) on the Rs. 6.10 crore bank facilities of Tech Green Enterprises (TGE). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

TGE established in 2015, is a Haryana-based partnership firm promoted by Mr. Praveen Kumar Binderdev Kamboj and Mr. Chetan Rai Kamboj. The firm is engaged in the manufacturing of laminates used in the furniture industry. Commercial operations commenced from November, 2016. The firm procures raw material such as craft paper, design paper and chemicals (phenol, mylemine, formaldehyde) from Gujarat and sells decorative laminated sheets across Punjab, Haryana, Uttar Pradesh and Orissa.

Unsupported Rating

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
