Rating Rationale

Acuité has downgraded the long-term rating to 'ACUITE B' (read as ACUITE B)from 'ACUITE B+' (read as ACUITE B plus) and reaffirmed the short term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs. 8.43 crore bank facilities of Shreekrishna Cotton Company (SKCC) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Shreekrishna Cotton Company (SKCC) is a Nagpur-based partnership firm established in 2013 by Mr. Narendra Chandak and Mr. Jaiprakash Chandak. The firm started off trading in cotton bales, seeds, oil & cotton cake initially and subsequently, commenced manufacturing of the above at Saoner Malegaon in Nagpur (Maharashtra) from FY2017.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
