Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B-**' (read as **ACUITE B minus**) and reaffirmed the Short term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 7.79 crore bank facilities of Rapha Diagnostics Private Limited. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Rapha Diagnostics Private Limited (RDPL), a Mumbai based company was incorporated in the year 2002 by Dr. Isac John. The company is engaged in trading of medical and diagnostic kits such as Elisa Kits, Rapid Test Kits, Urine Strips, Elisa Microplate Reader, Cell counter, Blood Glucometer to various diagnostic centers, labs and medical stores across India. In 2016, the company has also set up a manufacturing facility in Kerala to manufacture parts of diagnostic kits.

Unsupported Rating

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
