Acuite has reviewed the long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) on the Rs. 10.00 crore bank facilities of BRR Aqua Traders Private Limited (BAPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

The Andhra Pradesh based, BAPL directed by Harshavardhan Bhupathiraju, Rama Raju Venkata Prudvi Bhupathiraju and Kaacham Vidyanani was incorporated on 16 December, 2016. It is engaged in the trading of fish and prawns. The company sells prawns to local dealers in Bhimavaram and fish to customers in West Bengal, Bihar, Delhi and Assam among others.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
