Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE D**' (read as **ACUITE D**) on the Rs.10.00 crore bank facilities of B R R Aqua Traders Private Limited. The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

About the Company

Vijayawada-based BRR Aqua Traders Private Limited (BATPL), directed by Harshavardhan Bhupathiraju, Rama Raju Venkata Prudvi Bhupathiraju and Kaacham Vidyarani, was incorporated on December 16, 2016. It is engaged in the trading of fish and prawns. The company sells prawns to local dealers in Bhimavaram and fish to customers in West Bengal, Bihar, Delhi and Assam among others.

Non-cooperation by the issuer/borrower:
