Rating Rationale

Acuite has reaffirmed the long term rating of '**ACUITE B+**' (read as **ACUITE B plus**) and the short-term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 10.00 crore bank facilities of Blow Can Industries. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on best available information.

About the Company

Blow Can Industries (BCI), a partnership firm based in Tamil Nadu and established in 2002 by Mr. Ganesh Mal Baid, is engaged in the manufacturing and supply of plastic blow moulded drums, barrels, containers, caps and other plastic articles. The manufacturing facilities are located at Chennai and Pondicherry with installed capacity of 3 Lakh kg/annum. The firm also plans to enter into chemical industry packaging soon.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
