Rating Rationale

Acuite has reaffirmed the long term rating of ‘**ACUITE B-**’ (read as **ACUITE B minus**) and short term rating of ‘**ACUITE A4**’ (read as **ACUITE A four**) on the Rs. 25.00 crore bank facilities of High End Quality Constructions Private Limited (HEQCPL). The rating continues to be flagged as “Issuer Not-Cooperating” and is based on the best available information.

About the Company

Chennai based High End Quality Constructions Private Limited (HEQPL) was established in the year 2008 and the company is promoted by Mr. K. Siva Kumar and Mrs. T. Sudha. The company is engaged in executing civil construction projects and is a registered Class I contractor with the Public Works Department, Government of Tamil Nadu and Government of Pondicherry.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.
