Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) on the Rs.7.50 crore bank facilities of Sri Azhagu Nachiamman Modern Rice Mill. The rating continues to be flagged as "Issuer NotCooperating" and is based on the best available information.

About the Company

Sri Azhagu Nachiamman Modern Rice Mill, a Kallakurichi (Tamil Nadu) based firm was incorporated in the year 2010. Promoted by Mr. K. Gnanavel, is engaged in the milling of boiled and parboiled rice. The entity has unit located in Kallakurichi (Tamil Nadu) with installed capacity of 45 tons/day.

Unsupported Rating

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
