Rating Rationale

Acuité has downgraded the long-term rating to ‘**ACUITE B**’ (read as **ACUITE B**) from ‘**ACUITE B+**’ (read as **ACUITE B plus**) on the Rs.7.50 crore bank facilities of Sri Azhagu Nachi Amman Modern Rice Mill on account of information risk. The rating continues to be flagged as “Issuer Not-Cooperating” and is based on the best available information.

About the Company

Sri Azhagu Nachi Amman Modern Rice Mill, a Kallakurichi (Tamil Nadu) based firm was incorporated in the year 2010. Promoted by Mr. K. Gnanavel, is engaged in the milling of boiled and parboiled rice. The entity has unit located in Kallakurichi (Tamil Nadu) with installed capacity of 45 tons/day.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as “Issuer not-cooperating”, in line with prevailing SEBI regulations and Acuité’s policies.

Limitation regarding information availability

This rating is based on information available from sources other than the issuer / borrower (in the absence of information provided by the issuer / borrower) . Acuite endeavoured to gather information about the entity/industry from the public domain. Any rating with the suffix 'Issuer not cooperating' is assigned without any management
