Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) on the Rs. 10.07 crore bank facilities of Jagadish Feeds And Farms (JFF). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Karnataka-based, Jagadish Feeds And Farms (JFF) was incorporated in 2003. It is a partnership firm engaged in poultry farming. The firm has capacity of rearing 15.60 lakh broiler birds. Out of these 30,000 are reared at own farms and the rest on contract farming - popularly known as integration farming. The firm has a hatchery to set around 40,000 hatchable eggs per week and capacity of producing 18000 tonnes per year of chick feed at Hasan taluka. The firm is led by Shri Jagadish, who has over 18 years of experience in poultry broiler farming, hatching and integration.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuite endeavored to gather information about the entity/industry from the public domain. Therefore, Acuite cautions lenders and investors regarding the use of such information, on which the indicative credit rating is based.
