Rating Rationale

Acuité has downgraded the long-term rating to 'ACUITE B (read as ACUITE B)from 'ACUITE B+' (read as ACUITE B plus) on the Rs. 9.00 crore bank facilities of Integrity Mining Corporation Private Limited (IMPL) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Integrity Mining Corporation Private Limited (IMPL), promoted by Mr. Uday Bhaskar and Ms. Garikapati Swetha, was incorporated in 2013. The company is engaged in the trading of laterite, Granite, Eucalyptus Wood and is also into prawn culture. The storage facilities are located at Orissa. The procurement of laterite is done locally from mines in Vishakapatnam, while granite is procured from Warangal and Khammam in Telangana and exported to China. The registered office address of this company is in Telangana.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
