Rating Rationale

Acuité has downgraded the long-term rating to 'ACUITE B' (read as ACUITE Bf)rom 'ACUITE B+' (read as ACUITE B plus)on the Rs. 15.50 crore bank facilities of Cambria Solar Private Limited (CSPL) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Tamil Nadu based Cambria Solar Private Limited (CSPL) was incorporated in August, 2016 by Mr. Deepak Ponnuswamy and Mrs. Hima Bindu. The company is a special purpose vehicle (SPV) formed for building a 3 MW AC (3.3 MW DC) solar power plant in Bellary, Karnataka, generating power and supplying exclusively to Bangalore Electricity Supply Company Limited (BESCOM) for a period of 25 years at a pre-agreed price.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
