Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) and the short-term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs.8.00 crore bank facilities of Indigo Information Systems Private Limited (IISPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

Indigo Information Systems Private Limited, a Karnataka based company was incorporated in 2004, promoted by Mr. Madhusudhan Shetty, Mr. Harikumar V S and Mr. Santosh Udhayavar. Mr. Shetty. The company is engaged into providing IT solutions to the corporates. The company provides solutions such as RFID, Biometric, GPS, Communication solutions, GIS based survey and Analytics. Further, apart from these, the company also provides outsourcing and consultation solutions with emphasis on document management and archival solutions.
