Acuité has reviewed long-term rating of 'ACUITE BB-' (read as ACUITE double B minus) and short-term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs. 27.00 crore bank facilities of Shree Padmavati Engineers (India) Private Limited. This rating is now an indicative rating and is based on best available information.

Shree Padmavati Engineers India Private limited (SPEIPL) is part of the Shree Khodiyar group incorporated in 2002. The civil construction company, promoted by Mr. Bhimani and family, undertakes turnkey contracts (Plumbing & Sanitation), execution of utility services and drainage among others.

Analytical approach

Acuité has considered the standalone business and financial risk profiles of SPEIPL to arrive at the rating.

Non-cooperation by the issuer/borrower

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer / borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
