Acuite has reviewed the long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) on the Rs. 15.00 crore bank facilities of Savitri Ashirvaad Buildtech Limited (SABL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

SABL, a Hyderabad-based company, was incorporated in 2014 by Mr. Savitri Srikar Nag, Mr. Savitri Sri Harsha and Mr. J. Tirupathi (Directors). The company is engaged in the construction of residential and commercial complexes. The construction of a residential project 'Balaji Ashirvad Elite' constituting 160 flats was underway at Bannerghatta Road in Bangalore to be completed by 31 March, 2019. Around 65 percent of the construction was completed in December 2017.

#### Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
