Acuité has reviewed long term rating of '**ACUITE B+**' (read as **ACUITE B plus**) and the short term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 9.25 crore bank facilities of G P Tractors (GPT). This rating is now an indicative rating and is based on best available information.

G. P. Tractors (GP), a Barabanki-based partnership firm established in 2004 is a primary distributor of Mahindra & Mahindra tractors and light commercial vehicles in Uttar Pradesh. The firm is currently headed by Mr. Guptar Nath Jaiswal, Mr. Sharad Kumar Jaiswal and Mr. Ritesh Jaiswal, the partners. GP has 17 channel partners (dealers) in Uttar Pradesh.

#### Non-cooperation by the issuer/borrower

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer / borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
