# Rating Rationale

Acuité has reaffirmed the long-term rating of 'ACUITE B+' (read as ACUITE B Plus) and short term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs. 9.25 crore bank facilities of G P Tractors (GPT). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

### About the Company

G P Tractors (GPT), a Barabanki-based partnership firm established in 2004 is a primary distributor of Mahindra & Mahindra tractors and light commercial vehicles in Uttar Pradesh. The firm is currently headed by Mr. Guptar Nath Jaiswal, Mr. Sharad Kumar Jaiswal and Mr. Ritesh Jaiswal, the partners. GPT has 17 channel partners (dealers) in Uttar Pradesh.

### **Unsupported Rating**

### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
