Acuité has downgraded the long term rating to '**ACUITE B+**' (read as **ACUITE B plus**) from '**ACUITE BB-**' (read as **ACUITE double B minus**) on the Rs. 11.00 crore bank facilities of Aggarwal Fibres Private Limited. The rating continues to be flagged as "Issuer Not-Cooperating" and is downgraded on account of information risk.

AFPL, incorporated in 2016, is promoted by Mrs. Anju Goel & Mr. Ajay Kumar Gupta at Passina Kalan in Panipat (Punjab). The promoters established a new unit for manufacturing of Open-Ended yarn in the fineness of 16s and 20s counts. This can be treated as a backward integration project of the sister company situated adjacent to the unit.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
