Rating Rationale

Acuité has reaffirmed the long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) on the Rs. 11.00 crore bank facilities of Aggarwal Fibres Private Limited (AFPL). The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

About the Company

Aggarwal Fibres Private Limited (AFPL), incorporated in 2016, is promoted by Mrs. Anju Goel & Mr. Ajay Kumar Gupta at Passina Kalan in Panipat (Punjab). The promoters established a new unit for manufacturing of Open-Ended yarn in the fineness of 16s and 20s counts. This can be treated as a backward integration project of the sister company situated adjacent to the unit.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
