# **Rating Rationale**

Acuité has downgraded the long-term rating to 'ACUITE B' (read as ACUITE B) from 'ACUITE B+' (read as ACUITE B plus) on the Rs. 11.00 crore bank facilities of Aggarwal Fibres Private Limited (AFPL) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

#### **About the Company**

Aggarwal Fibres Private Limited (AFPL), incorporated in 2016, is promoted by Mrs. Anju Goel & Mr. Ajay Kumar Gupta at Passina Kalan in Panipat (Punjab). The promoters established a new unit for manufacturing of Open-Ended yarn in the fineness of 16s and 20s counts. This can be treated as a backward integration project of the sister company situated adjacent to the unit.

#### **Unsupported Rating**

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit
