Rating Rationale

Acuite has downgraded the long-term rating to '**ACUITE B+**' (read as **ACUITE B plus**) and the short term rating to '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 31.50 crore bank facilities of Rawalwasia Textile Industries Private Limited (RTIPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is downgraded on account of information risk.

About the Company

Rawalwasia Textile Industries Private Limited (RTIPL) was established in 1988 by Mr. Samir Agarwal and Mr. Dinesh Dayama. The company is engaged in trading of coal and is based out of Surat (Gujarat).

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
