Acuite has reviewed long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) and short term rating of '**ACUITE A4**' (read as '**ACUITE A four**') on the Rs. 35.00 crore bank facilities of EPR Centre For Cancer Research And Bioinformatics (EPR). This rating is now an indicative rating and is based on best available information.

EPR incorporated in 2006 is a direct subsidiary of Vitane Pharmaceuticals Private Limited (VPPL) which is engaged in manufacturing pharmaceuticals, biotechnology products and orthopaedic support products which are sold domestically as well as in the export markets. EPR was yet to start its commercial operations, which was expected to start from July 2018. VPPL is setting up a technology-centric biotech company to focus on monoclonal antibodies for auto-immune diseases. The proposed R&D lab and GMP manufacturing facility at Hyderabad is estimated to be built at a total cost of Rs.79.18 crore which includes Rs.35.00 crore debt funding and remaining as equity.

Non-cooperation by the issuer/borrower

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer / borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
