Rating Rationale

Acuité has reaffirmed the long-term rating of 'ACUITE B+' (read as ACUITE B plus) on the Rs. 6.50 crore bank facilities of Swastika Printing and Packaging (SPP). The rating continues to be flagged as "Issuer NotCooperating" and is based on the best available information.

About the Company

Established in 2009, Swastika Printing & Packaging (SPP) is a partnership firm actively managed by the partners, namely, Mr. Jitender Kumar and Mr. Narender Kumar. It is located in Himachal Pradesh. The company is engaged in manufacturing of mono cartons and corrugated boxes for industrial packaging. Its manufacturing unit is based in Kala Amb town, which is in Sirmour district (Himachal Pradesh).

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
