**The issuer did not co-operate; based on best available information.

Acuité has downgraded the long term rating to '**ACUITE BB**' (**read as ACUITE double B**) from '**ACUITE BB+**' (**read as ACUITE double B plus**) and short term rating of '**ACUITE A4+**' (**read as ACUITE A four plus**) on the Rs. 31.00 crore bank facilities of Kamal Timbers India Private Limited (KTPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is downgraded on account of information risk.

KTPL was established as a proprietorship firm in 1991 under the name of 'Kamal timbers and Lotus Timber & Plywood' and later in 2005 was converted to a private limited entity by Mr. Kamal Chawla and Mrs. Alka Chawla. The company is engaged in the processing and trading of timber. KTPL imports timber from South East Asian countries such as Singapore, Malaysia, Hong Kong, New Zealand and South Carolina and processes it in its sawmills. KTPL has three units at Haryana, Gujarat and New Delhi.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
