### **Rating Rationale**

Acuité has downgraded the long-term rating to 'ACUITE B' (read as ACUITE B)from 'ACUITE B+' (read as ACUITE B plus) on the Rs.15.00 Crore bank facilities of P Sri Ramulu on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

#### About the Company

Established in 1991, P Sri Ramulu is a proprietorship concern established by Mr. Sriramulu. The Chennai based firm is engaged in the wholesaling and retailing of rice. The firm sells rice through its departmental store at Sowcarpet, Tamil Nadu and caters to local customers as well as hotels.

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
