Rating Rationale

Acuite has reaffirmed the long-term rating of ‘**ACUITE D’ (read as ACUITE D)** on the Rs. 8.04 crore bank facilities of Dhanpati Agro Udyog Private Limited. The rating continues to be flagged as “Issuer Not Cooperating” and is based on the best available information.

About the Company

Uttar Pradesh-based Dhanpati Agro Udyog Private Limited (DAUPL) was incorporated in 2010. The company is promoted by Mr. Subhash Chand Jaiswal and Mr. Brahma Nand Jaiswal. DAUPL is engaged in rice milling.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
