Acuité has downgraded the long-term rating to '**ACUITE B+**' (read as **ACUITE B plus**) from '**ACUITE BB-**' (Read as **ACUITE double B minus**) and downgraded the short-term rating to '**ACUITE A4**' (read as **ACUITE A four**) from '**ACUITE A4+**' (read as **ACUITE A four plus**) on the Rs.6.90 crore bank facilities of Michael and Michael Pipes Private Limited (MMPPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is downgraded on account of information risk.

The Kerala-based Michael and Michael Pipes Private Limited (MMPPL) was incorporated in 1990 by Mr. T.M. Michael. The company undertakes civil work and is also engaged in the manufacturing of R.C.C pipes

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer / borrower failed to submit such information before the due date.

Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with an unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
