#### **Rating Rationale**

Acuité has downgraded the long-term rating to 'ACUITE B-' (read as ACUITE B Minusf)rom 'ACUITE B+' (read as ACUITE B plus) and reaffirmed the short-term rating of 'ACUITE A4' (read as ACUITE A Four) n the Rs.48.00 Cr. bank facilities of Innowave It Infrastructures Limited (IIIL).

The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

The downgrade is attributed to the initiation of the Corporate Insolvency Resolution Process (CIRP) against IIIL by an Operational Creditor and admission of the same, as per the National Company Law Tribunal (NCLT) order dated 24<sup>th</sup> March 2025.

#### **About the Company**

Mumbai-based, Innowave IT Infrastructures Limited (IIIL) was incorporated in 1995 and is currently headed by Mr. Anant Raghute. The company is engaged in providing IT infrastructure, and staffing services to central, state (Maharashtra), local government and government entities.

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and noncooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.

# Limitation regarding information availability

This rating is based on information available from sources other than the issuer / borrower (in the absence of information provided by the issuer / borrower) . Acuite endeavoured to gather information about the entity/industry from the public domain.
