Acuité has reviewed long-term rating of „**ACUITE B (read as ACUITE B)** and short term rating of '**ACUITE A4 (read as 'ACUITE A four')** on the Rs. 11.86 crore bank facilities of Alumil Buildmate Private Limited (ABPL). This rating is now an indicative rating and is based on best available information.

ABPL was incorporated in 2016 by Mrs. Seema Anand and Mr Narsaiah Kadari. The company manufactures aluminium windows & doors and caters to real estate developers as well as the commercial segment. M/s Alumil Greece has appointed the company as its authorised fabricator for India. The company's manufacturing facility is located in Telangana with a capacity of 40310 sq mtrs per annum

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.
