Rating Rationale

Acuité has downgraded the long-term rating to 'ACUITE B-' (read as ACUITE B minus) from 'ACUITE B' (read as ACUITE B) on the Rs. 16.00 crore bank facilities of Mahaveer Electric Agencies Madras on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Chennai based, Mahaveer Electric Agencies Madras is a proprietorship firm established in 1975 by Mr. Sumermal and currently managed by his son, Mr. Suresh Kumar (Proprietor). The firm provides end to end solution in the supply of electrical fittings and lighting solutions to industrial, residential, and corporate clients. The firm is engaged in the supply and distribution of Philips bulbs, Finolex wires, Philips garden bulbs, lamps, luminaries, electric gears, and accessories.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.
