**Rating Rationale**

Acuite has downgraded the long-term rating to '**ACUITE B-**' (read as **ACUITE B minus**) from '**ACUITE B**' (read as **ACUITE B**) on the Rs. 23.00 crore bank facilities of Foyer Mines and Minerals Private Limited (FMPL) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

**About the Company**

Foyer Mines and Minerals Private Limited (FMPL) incorporated on 26 May, 2016, has been formed for the purpose of quarrying various kinds of rocks and minerals including manufacture of M-sand and plaster sand. The Directors of the company are Mr. M. Kondal Rao and Mr. Kavishwar Rao. The company has been set up a stone crusher plant at Bangalore.

**Non-cooperation by the issuer/borrower:**

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

**Limitation regarding information availability**

This rating is based on information available from sources other than the issuer / borrower (in the absence of information provided by the issuer / borrower) .
