**Rating Rationale**

Acuite has reaffirmed the long-term rating of 'ACUITE B+' (read as ACUITE B plus) and short term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs. 39.00 crore bank facilities of Trident Techlabs Private Limited (TTPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

**About the Company**

Incorporated in 2000, Trident Techlabs Private Limited is a Delhi based software company that caters to various industries including education and power sector. The software is used for simulation design, prototype and for identifying distribution losses in the power sector. TTPL was promoted by Mr. Sukesh Naithani and Mr. Praveen Kapoor.

**Non-cooperation by the issuer/borrower:**

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and noncooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
