Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE BB-**' (read as **ACUITE double B minus**) the short-term rating of '**ACUITE A4+**' (read as **ACUITE A four plus**) on the Rs. 9.96 crore bank facilities of Techno Blow Moulders Private Limited (TBMPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Techno Blow Moulders Private Limited incorporated in 2009 is part of the Blow Group of companies. The group, led by Mr. C. M. Baid (Founder) came into existence in 1979. The company is engaged in the manufacturing of plastic blow moulded containers for pharmaceutical, packaging, food and beverage industries. It caters to a reputed client base. The Telangana-based company procures the majority of its raw materials (HDPE Granules) from Haldia Petrochemical Industries Limited, Reliance, Indian Oil Corporation Limited, Gulf Polymers, Qatar and also does deem imports from Saudi Arabia and Singapore.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in

the absence of information provided by the issuer/borrower). Acuité endeavored to gather information about the entity/industry from the public domain. Therefore, Acuité cautions lenders and investors regarding the use of such information, on which the indicative credit rating is based.
