Acuité has reviewed the long term rating of '**ACUITE B+** (read as **ACUITE B plus**) on the Rs. 6.50 crore bank facilities of Gautam Silks (GS). This rating is now an indicative rating and is based on best available information.

GS was established in 2005 by Mr. Gautam Malhotra. The company is engaged in manufacturing of silk fabric with an installed capacity of 170000 metres per month. The manufacturing unit is located at Bangalore (Karnataka). The company majorly imports its raw material, i.e. raw silk, directly from China. GS caters to the local retailer and embroiders in local market of Punjab, Delhi, Kolkata, Bangalore and Mumbai, among others.

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
