Acuité has downgraded the long term rating to '**ACUITE B+**' (read as **ACUITE B plus**) from '**ACUITE BB-**' (read as **ACUITE BB minus**) and short term rating '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 6.00 crore bank facilities of Amrut Construction. The rating continues to be flagged as "Issuer Not-Cooperating" and is downgraded on account of information risk.

AC was established in 2000 as a proprietorship firm by Mr. Raj Kumar Rochlani. Subsequently, the constitution changed into partnership in 2017 with the induction of partners, Mr. Raj Kumar Rochlani, Mr. Ritesh Rochlani, Mr. Rameshwar Rochlani, and Ms. Sangeeta Rochlani. The firm is into executing of civil projects of roads, buildings in the districts of Nagpur, Chandrapur, Gadchiroli, Bhandara, Gondhia in Maharashtra. The firm is based out of Nagpur, Maharashtra.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
