Rating Rationale

Acuité has reaffirmed the long-term rating of 'ACUITE B+' (read as ACUITE B plus) and the short-term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs. 6.00 crore bank facilities of Amrut Construction(AC). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Amrut construction was established in 2000 as a proprietorship firm by Mr. Raj Kumar Rochlani. Subsequently, the constitution changed into partnership in 2017 with the induction of partners, Mr. Raj Kumar Rochlani, Mr. Ritesh Rochlani, Mr. Rameshwar Rochlani, and Ms. Sangeeta Rochlani. The firm is into executing of civil projects of roads, buildings in the districts of Nagpur, Chandrapur, Gadchiroli, Bhandara, Gondhia in Maharashtra. The firm is based out of Nagpur, Maharashtra.

Non-cooperation by the issuer/borrower:
