**Rating Rationale**

Acuite has reaffirmed the long-term rating of '**ACUITE BB-**' (read as **ACUITE double B minus**) and short-term rating of '**ACUITE A4+**' (read as **Acuite A four plus**) on the Rs.16.00 crore bank facilities of Jagdamba Ispat Private Limited (JIPL). The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

**About the Company**

JIPL was established in 2004 in Kolkata by Mr. Sandeep Murarka, Mr. Sanjay Kumar Murarka, and Mr. Arun Kumar Agarwal. The company manufactures MS ingots at Durgapur (West Bengal) with installed capacity of 54,000 MTPA.

**Non-cooperation by the issuer/borrower:**

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with an unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is therefore being flagged as "Issuer not cooperating", in line with prevailing SEBI regulations and Acuite's policies.

**Limitation regarding information availability:**

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuite endeavored to gather information about the entity/industry from the public domain. Therefore, Acuite cautions lenders and investors regarding the use of such information, on which the indicative credit rating is based.
