Acuité has downgraded the long-term rating to '**ACUITE B+**' (read as **ACUITE B plus**) from '**ACUITE BB-**' (read as **ACUITE double B**) on the Rs. 16.46 crore bank facilities of Krishna Global Marbles and stones LLP (KGMS). The rating continues to be flagged as "Issuer Not-Cooperating" and is downgraded on account of information risk.

KGMS was established in 2015 as a Limited Liability Partnership (LLP) by Mr. Bajrangbali Mulchand Varma, Mr. Prajapati Dipakkumar Jagdishbhai and Mr. Varma Rajendra Mulchand. The firm is engaged in the processing and trading of marble, tiles, stone and specialises in Italian marble. The manufacturing unit is located at Valsad (Gujarat).

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
