Rating Rationale

Acuite has withdrawn the long term rating of '**ACUITE BB**' (read as **ACUITE double B**) and the short term rating of '**ACUITE A4+**' (read as **ACUITE A four plus**) on the Rs.29.50 Cr. bank facilities of Sai Deepa Rock Drills Private Limited (SDRDPL). The rating continuous to be flagged as an 'Issuer Not-Cooperating' based on best available information.

The rating is being withdrawn on account of the request received from the company and the NOC received from the banker as per Acuite's policy on withdrawal of ratings.

About the Company

Hyderabad based, SDRDPL was incorporated in 2000 by Mr. Ranga Rao Nutakki and family. It is engaged in the manufacturing of rock drilling tools which are used in various industries such as water well, oil/gas mining, quarry, and construction, tunneling and well drilling. The company started its operations in 2001 from its manufacturing unit based out of Cherlapally at Hyderabad (Telangana). SDRDPL has 1.1 MW solar power plant for captive use located in Bhongiri (Telangana).

Non-cooperation by the issuer/borrower

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer / borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with an unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.
