Acuité has reviewed the long-term rating of '**ACUITE B+** (read as **ACUITE B plus**) on the Rs.15.00 crore bank facilities of Konkan Gyanpeeth (KG). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

KG was established in 1989 by Late Mr. Prabhakar Narayan Dharkar (Ex-Minister-Maharashtra Government). It is registered as a charitable trust under the Societies Registration Act 1860 and The Bombay Public Trust Act 1950 on 30 September, 1989. The trust runs four colleges - Konkan Gyanpeeth College of Engineering (Karjat), Rahul Dharkar College of Pharmacy & Research Institute (Karjat), Konkan Gyanpeeth Karjat College of Arts, Science & Commerce and Konkan Gyanpeeth Uran College of Commerce and Arts. The colleges offer a range of courses in science, arts, commerce, engineering and pharmacy.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with an unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
