Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) on the Rs.15.00 crore bank facilities of Konkan Gyanpeeth (KG). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Konkan Gyanpeeth (KG) was established in 1989 by Late Mr. Prabhakar Narayan Dharkar (Ex-Minister-Maharashtra Government). It is registered as a charitable trust under the Societies Registration Act 1860 and The Bombay Public Trust Act 1950 on 30 September, 1989. The trust runs four colleges - Konkan Gyanpeeth College of Engineering (Karjat), Rahul Dharkar College of Pharmacy & Research Institute (Karjat), Konkan Gyanpeeth Karjat College of Arts, Science & Commerce and Konkan Gyanpeeth Uran College of Commerce and Arts. The colleges offer a range of courses in science, arts, commerce, engineering and pharmacy. The registered office is located in Karjat, Raigad.
