Rating Rationale

Acuité has downgraded the long-term rating to ‘**ACUITE B-**’ (read as **ACUITE B minus**) from ‘**ACUITE B**’ (read as **ACUITE B**) and reaffirmed the short term rating of ‘**ACUITE A4**’ (read as **ACUITE A four**) on the Rs. 8.00 crore bank facilities of VBE Projects Private Limited on account of information risk. The rating continues to be flagged as “Issuer Not-Cooperating” and is based on the best available information.

About the Company

The Mumbai based, VBE Projects Private Limited Incorporated in 2011 and promoted by Mr. Chakkingal Aniyath Ragunandan, Mr. Venkat Bhagavat Eswaran and Mr. Prabhu Krishnamachari. Previously, the company was operating as a partnership firm, under the name of Vikas Builders and Erectors. The company is mainly engaged in undertaking sub contracting works for the government and private players. The company undertakes a variety of works which includes jobs such as piping, piling, heavy civil works, structural fabrication and erection for segments including industrial buildings, water and wastewater plants, ETP, STPs, Steel Plants among others.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as “Issuer not-cooperating”, in line with prevailing SEBI regulations and Acuité’s policies.

This rating is based on information available from sources other than the issuer / borrower (in the absence of information provided by the issuer / borrower) . Acuite endeavoured to gather information about the entity/industry from the public domain.
