Rating Rationale

Acuité has reaffirmed the long-term rating to '**ACUITE B+**' (read as **ACUITE B plus**) and the short-term rating to '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 18.00 crore bank facilities of Sanimo Polymers Private Limited (SPPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is reaffirmed on account of information risk.

About the Company

Sanimo Polymers Private Limited, incorporated in 1986, is promoted by Mr. Suresh Shah and Mr. Tejas Shah. The company is engaged in manufacturing and processing of dyes and polyester yarn, including embroidery yarn, multicoloured fancy yarn, and carpet yarn. Its manufacturing facility is located at Surat (Gujarat). The facility has a capacity of 220 tonnes per month and the utilisation is around 200 tonnes per months, i.e. around 90 percent.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
