Acuité has reviewed the long-term rating of '**ACUITE B**' (read as **ACUITE B**) on the Rs. 7.50 crore bank facilities of Torrance Enterprise (TE). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

Surat-based TE was established in 2016. The firm is promoted by Mr. Jignesh Amin and Mrs. Anupa Amin. They are engaged in the real estate business of constructing a residential property under the name Torrance.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
